Multi-point boltwork with Yale rim deadlock<sup>7</sup>

#### **Notes:**

- 1. The double leaf doorsets achieve the security ratings noted irrespective of whether the sprung tower bolts on the passive leaf are engaged.
- 2. The doorset achieves at least a Security Rating 1 when placed in the minimum locked condition i.e. when only one of the sprung tower bolts on the passive leaf is engaged.
- 3. Doorsets higher than 2.5 m incorporate two identical locking mechanisms on the active leaf.
- 4. Fail secure version only.
- 5. The resistance of the access control locks to "non-mechanical" attack has not been assessed as it is outside the scope of LPS 1175. Likewise, the approval does not cover possible effects of any susceptibilities relating to the functionality and performance of any access control equipment that may be used to operate these locking systems. This is because the scope of access control devices and system configurations that may be used with these locking systems is "infinite". It is therefore recommended that the user satisfies themselves that the components used are either resistant to mechanical and other forms of tampering/abuse, or that they are suitably protected from such tampering/abuse and are resistant to any environmental conditions/interference that may cause the locking system to disengage.
- 6. The resistance of the mechatronic cylinders to "non-mechanical" attack has not been assessed as it is outside the scope of LPS 1175. Likewise, the approval does not cover possible effects of any susceptibilities relating to the functionality and performance of ancillary equipment that may be used in conjunction with those cylinders. It is therefore recommended that specifiers satisfy themselves that the components used are either resistant to electronic methods of attack, or that they are suitably protected from such tampering/abuse and are resistant to any environmental conditions/interference that may cause the locking system to disengage.
- 7. The 'multi-point boltwork with Yale rim deadlock' may be fitted as a supplementary locking system to the rear of the single leaf padlockable doorset or active leaf of the double leaf padlockable doorset. However, the doorsets only achieve the security rating noted when the padlockable shroud is secured in the closed condition using one of the padlocks listed in the table of 'padlock options' above.
- 8. The approval covers the doorsets when installed directly into structural timber surrounds, that are at least 120 mm deep, using the method of installation defined on drawings 'Security Rating 2 GRP Doorsets' (Revision 16 dated 4 February 2014) and 'Security Rating 3 GRP Doorsets' (Revision 16 dated 4 February 2014).
